

## 2009 RICHMOND JUNIOR TENNIS CIRCUIT

The Richmond Junior Tennis Circuit (RJTC) is designed to make competitive play more accessible for our juniors. These tournaments are for non-ranked juniors playing bantam or intermediate tennis or looking to start playing Futures tournaments. These one-day tournaments will be held on Saturdays.

### EVENTS

The singles events will be:

Boys 8, 10, 12, & 14

Girls 8, 10, 12, & 14

(Minimum of 4 players to hold an event. If a draw has less than 4, players may be moved or divisions may be combined to make a draw.)

### AGE ELIGIBILITY

The age division you play in is determined by the age you will be at the end of the month of any given tournament. Ex./ If the junior is 8 years old, but turns nine on June 28<sup>th</sup>, he/she must play in the 10 and under age division starting with tournaments June 7<sup>th</sup>. Players having achieved a top 75 Mid Atlantic standing must play up an age division.

### REGISTRATION

The entry fee is \$16.00/tournament and must be in the hands of the tournament director by the entry deadline, 6:00 p.m. on Wednesday prior to each tournament. You can register by mailing your entry to the clubs listed on the back of this entry (make checks payable to the club at which you are playing).
